Application Form Instructions

Thank you for your interest in the Karuk Tribe's Áan Chúuphan Broadband services. In order to apply for service, please fill out all of the information on page 2 of this form. Then turn in your application in-person at the Karuk Tribe Department of Natural Resources office in Orleans, or mail your packet to the address listed.

Once your application has been received, you will be contacted by an Áan Chúuphan service technician to schedule an appointment to test Broadband access from your residence or business. Regular service appointments will be scheduled between 9 AM and 4 PM, Monday through Friday. Evening and Weekend appointments may be requested, but must be scheduled at least a week in advance. The technician will visit your location and install a small radio and antenna, which will be mounted to the side of your building. A wire will be run from the radio to inside your building. Once a strong wireless connection is established, the service will be activated, and the first payment for services will be expected.

Please note that if a strong wireless signal cannot be achieved, Áan Chúuphan services will not be immediately activated and no payment will be required until the service is established. In order to achieve a strong wireless signal, tree trimming or other measures may be required by the property owner.

Áan Chúuphan broadband service is subject to the Áan Chúuphan Internet Service Agreement, including the Áan Chúuphan Internet Terms and Conditions and the Áan Chúuphan Internet Acceptable Use Policy.
